The Distinguished Service Award has been presented since 1984 at the State Convention. It is given to a member of NYS AFCSE who has made an outstanding contribution to our professional organization.

Any member of NYS AFCSE may nominate a candidate for the Distinguished Service Award. There is no limit on the number of nominees from each local area. The following nomination form may be duplicated.

Presentation

The recipient will receive an engraved silver plate at the State Convention.

Criteria for Award

The recipient must:

- *be a current or past member of NYS AFCSE.
- *have made an outstanding contribution to NYS AFCSE

Nomination Procedure

1. The Awards Chairperson shall request nominations through a winter notice to Area Coordinators and NYS AFCSE Board members.
2. The nominations form emailed electronically to the NYS AFCSE Awards Chairperson, *postmarked no later than April 1.*
3. Any NYS AFCSE member can make a nomination for the Distinguished Service Award by submitting a completed nomination form to the State Awards Chairperson by the due date.
