The New York State Association of Family and Consumer Science Educators is an organization specifically designed to further the goals of family and consumer science education in New York State.

NYSHETA was founded in 1961 and received its charter from the Board of Regents on September 26, 1969. On May 4, 1995, the name was changed to New York State Association of Family and Consumer Science Educators.

The goals of NYS AFCSE, as outlined in the constitution, are:

- to provide an organization for official representation of family and consumer science teachers.
- to unify interest and efforts in strengthening the program of family and consumer sciences in education in the schools and colleges of New York State.
- to stimulate and coordinate research and experimentation in the field of family and consumer science education.
- to interpret family and consumer science education in the light of changing needs.

AREA PROGRAM

NYS AFCSE offers unique representation and participation opportunities to its members via the local area program.

The state is divided into twenty-three areas (by counties). Each area, staffed by a local area-coordinator and assistants, provides activities designed to meet the needs and interests of that particular area.

The area program also insures a more direct representation of local needs to the executive board, as each area-coordinator serves as a member of that board. A percentage of state dues are returned to the area to assist with area program expenses.

NYS AFCSE MEMBERSHIP CLASSIFICATIONS:

- 1. Active Member** - Active members shall be teachers and administrators of family and consumer science in NYS who hold a degree or certification in any field of family and consumer science and who have been actively engaged in family and consumer science education for at least one year.
- 2. Advocate Member** - Advocate members shall be any person who is not actively engaged in teaching family and consumer science but is interested in its programs.
- 3. Associate Member** - Associate members shall be teachers and administrators who are not gainfully employed in family and consumer science education in NYS and hold a degree or certification in any field of family and consumer science.
- 4. Beginning Teacher** - Beginning members shall be first year teachers of family and consumer science education in NYS, and hold a degree or certification in any field of family and consumer science.
- 5. Student Member** - Student members are college students pursuing a degree or certification and seeking teacher certification in family and consumer science education.
- 6. Retired Members** - Retired members are teachers of family and consumer science education and hold a degree or certification in any field of family and consumer science and whose retirement begins during the school year covered by the membership application.
- 7. Lifetime Retired Member** - Lifetime members are teachers of family and consumer science education in NYS and hold a degree or certification in any field of family and consumer science. Members may elect lifetime membership and pay a one-time fee for membership the year their retirement begins.
